Welcome to Salt Creek Resort & RV on Lake Shasta! We hope your stay with us is pleasant and enjoyable. To help us ensure the safety and satisfaction of all guests, including you and your pets, please review the following policies and guidelines.

Please read and **INITIAL** by each of the following:

- _____ A maximum of 2 dogs are allowed per cabin and 2 maximum per RV Site.
- _____ The only animal that is allowed on resort property is a DOG. The resort strictly prohibits ANY other animal other than a dog. If your dog exhibits aggressive behavior towards other guests or resort staff, you agree that you will remove the dog. Resort Management will make the final decision as to what constitutes "aggressive behavior," and you agree to follow management's decision.
- _____ I agree that my pet has received, and is current with all required shots and immunizations.
- _____ I agree to use the dog waste pick up station and dispose of waste in the outdoor garbage receptacles.
- _____ I agree to keep my dog with me or a designated individual at all times. I will not leave him/her unattended in my cabin/RV Site (Your neighbors won't be very happy when Fido misses you).
- _____ I agree to pay \$10 pet fee per night per pet if staying in a cabin that will be added to the bill. *This fee is non-refundable. No Fees apply if staying in a RV Site.*
- _____ I agree to keep my dog on a leash or in a carrier while on resort property and in public areas.
- _____ I agree to accept full responsibility for any and all damages/harm and/or unusual degree of soiling caused by my pet during my stay at the resort. *The resort accepts no responsibility for a pet or pet owner who does not follow the items listed on this waiver.*
- _____ I agree to pay any additional cleaning or repair bills should they be required and authorize the resort to charge my credit card for such damages, even if they are discovered following my departure from the resort. This includes, but is not limited to, odors, stains, excessive hair, and flea treatment of a cabin.
- _____ I agree to prevent noise or any other disturbance by my dog, in the interest of other resort guests.
- _____ I agree that, should my dog create any disturbances, which cause complaints to be made to the resort by other occupants or personnel of the resort, at the request of the resort manager, I shall immediately make arrangements to house my dog elsewhere outside the resort or leave the resort without reimbursement.

INDEMNIFICATION:

INDEMNITY FOR BODILY INJURY AND PROPERTY DAMAGE: To the fullest extent permitted by California law, I shall defend, indemnify and hold harmless the owner and its agents, successors, assigns, consultants, affiliated companies and employees (the Indemnitees) from any and all claims, allegations, demands, causes of action, arbitration, costs, damages, expenses, actual attorney's fees and costs, liability, in law or in equity, of every kind and nature whatsoever arising out of or in connection with my dog(s) including the active and passive negligent acts or omissions of the indemnitees but for their sole negligence or willful misconduct.

DUTY TO DEFEND: To the fullest extent permitted by California law, I shall completely defend the indemnitees. This duty to defend includes all claims, allegations, causes of action, suits, arbitration or administrative proceedings. At my sole expense or the expense of my insurer, I/we will pay defense fees and costs to directly defend the indemnitees with a qualified lawyer. The Duty To Defend shall extend to claims alleged after my stay at Salt Creek Resort as well as now.
